## **Tractor Show Rules & Safety Guidelines**

To ensure a safe and enjoyable experience for all attendees, the following rules must be followed by all exhibitors:

### **1. Parking & Movement**

- All tractors must arrive during designated load-in times. (7AM-9:30AM) Tractors must be in place in the park exhibit area by 9:30AM.
- Once your tractor is parked in its assigned space, **it may not be started or moved** until official release at the end of the show. (After 5PM or until Fort Mill Police Dept. has given direction for safe movement)
- No driving or repositioning tractors during event hours.
- Keys must be removed from the ignition when tractor is unattended.

### **2. Safety & Supervision**

- Exhibitors are responsible for supervising their tractor and display area at all times.
- Do not allow attendees, especially children, to climb on or operate tractors unless you are directly assisting them.
- If allowing photos on tractors, the owner must be present and assisting.
- Keep all sharp edges, hitch components, and moving parts secured or blocked.
- Immediately report any injuries or unsafe behavior to event staff.

### **3. Display Setup Rules**

- No tents, canopies, or large shade structures are permitted in the tractor show area.
- Small personal umbrellas attached to chairs are permitted.
- You may bring:
  - Lawn chairs
  - Small personal supplies
  - Informational signage about your tractor
- All items must stay within your assigned display space.

### **4. Conduct & Appearance**

- Exhibits must be family-friendly and appropriate for a public festival environment.
- No selling of merchandise unless pre-approved by festival organizers.
- No excessive revving of engines or loud demonstrations.



## 5. Cleanliness & Environmental Safety

- Drip pans are required for tractors with known quantifiable (heavy) leaks.
- Exhibitors are responsible for cleaning up any leaks, spills, or trash in their area.
- Fueling of tractors on festival grounds is prohibited during event hours.

## 6. Departure

- Tractors must remain on display until the official end time, 5PM.
- Early departure is not permitted.
- For safety reasons, tractors will be released in a controlled manner.

**Failure to follow these rules may result in removal from the show and ineligibility for future participation.**

## 7. Official Entry Placards

- Each registered exhibitor will receive an official Tractor Show placard upon arrival and check-in.
  - The placard must be clearly displayed on or directly in front of the tractor at all times during the event.
  - The placard will include entry information such as:
    - Exhibitor name
    - Tractor make, model, and year
    - From (location)
  - Exhibitors may display additional informational signage about their tractor, but it must not obstruct the official placard.

## **Tractor Show Parking & Driving Instructions**

To ensure safety and smooth traffic flow, all exhibitors must follow these directions exactly.

### **Tractor Arrival Time: 7AM-9:30AM**

**(Do not arrive early or you will be interfering with our vendor restocking time)**

You must have your tractor placed in the park display area by 9:30AM so plan to arrive and park vehicles/trailers on Springs Property off Bass Street in a timely manner to ensure your tractors are placed by this time.

## **Trailer & Tow Vehicle Parking**

All vehicles and trailers must park at **Springs Property located off Bass Street** before driving tractors into the park.

### **Directions to Springs Property:**

1. From **I-77**, take **Exit 85** to **N. White Street (Highway 160 E)**.
  2. Turn **right onto Bass Street**.
  3. Follow posted Tractor Show Parking signs onto **Springs Property**, located off Bass Street.
  4. Offload your tractor at Springs Property.
  5. Park your truck and trailer in designated areas as directed by staff.

## **Driving Tractors Into the Park**

After unloading:

1. Exit Springs Property and proceed to **N. White Street**.
2. Turn **right onto N. White Street**.
3. Drive approximately **2 blocks** to **Sydney Johnson Street**.
4. Turn **right onto Sydney Johnson Street**.
5. Make a **left into the park at the curb ramps**.
6. Follow all **Staff Directions** to your assigned display space.

 Drive slowly and use caution. Be mindful of pedestrians and festival traffic at all times.

## End of Event – Tractor Exit Procedure

**Tractors will Exit the park display area at 5PM following staff directions. Please have your tractors removed from the park by 7PM.**

At the conclusion of the show, tractors must exit using the same route in reverse order, following staff instructions.

1. Exit the park and turn **right onto Sydney Johnson Street.**
2. Proceed to **N. White Street.**
3. Turn **left onto N. White Street.**
4. Drive approximately **2 blocks.**
5. Turn **left onto Bass Street.**
6. Return to **Springs Property.**
7. Load tractors and follow all Staff Directions when exiting.

 No tractors may leave early.

## Important Reminders

- Follow all posted signage and staff instructions.
  - Maintain safe speeds at all times.
  - Yield to pedestrians.
  - Use hazard lights if available.
  - Keep tractors in low gear while entering and exiting.

# FESTIVAL RULES

- The following items are not permitted at the festival:
  - Animals of any kind (except service animals)
  - Outside food and beverages
  - Coolers
  - Golf Carts
  - Bicycles
  - Firearms/Weapons
  - Illegal narcotics
  - Drones cannot be flown in or above Walter Y. Elisha Park during the festival.
- Children under 16 must be accompanied by an adult.
- Profanity, both spoken and on attire, is not permitted at the festival.
- Smoking and vaping are not allowed at the festival.
- Only approved vendors are permitted to sell at the festival.
- Soliciting and/or demonstrations of any kind are not permitted.
- Offensive, disruptive or disorderly conduct will not be tolerated.
- You must be at least 21 years old to purchase alcohol from the marked tents.
- Attendees must exit the festival grounds at the conclusion of the festival events.
- The SC Strawberry Festival and the Town of Fort Mill are not responsible for any items that are lost, stolen, left unattended, or left on the premises after the conclusion of the festival.
